INTRODUCTION

The purpose of this circular is to provide you with information in respect of the resolutions to be proposed at the 2019 Annual General Meeting for the approval of (a) proposed re-election of the Retiring Directors; (b) the grant to the Directors of the Proposed Issue Mandate; (c) the grant to the Directors of the Proposed Buy-back Mandate; and (d) the extension of the Proposed Issue Mandate to issue Shares by adding to it the aggregate number of the issued Shares bought back under the Proposed Buy-back Mandate.

PROPOSED RE-ELECTION OF RETIRING DIRECTORS

As at the Latest Practicable Date, the executive Directors are Mr. Jiang Zhaobai, Mr. Lam Cheung Shing, Richard, Mr. Chen Yi, Ethan and Mr. Shen Angang; and the independent non-executive Directors are Mr. Ho Yiu Yue, Louis, Mr. Ko Ming Tung, Edward and Professor Shan Zhemin.

Mr. Jiang, Zhaobai ("Mr. Jiang")

Mr. Jiang, aged 56, has been appointed as an executive Director of the Company and Chairman of the Board in September 2012. He is also the chairman of the board of Shanghai Pengxin Group Co., Ltd. ("Pengxin Group"). Mr. Jiang is the founder of Pengxin Group and Shanghai Pengxin Real Estate Development Co., Ltd. ("Pengxin Real Estate") and has 25 years experience in real estate development and investment. He was the chairman of Pengxin Group during the period from April 1997 to May 2000 and the chairman of Pengxin Real Estate during the period from January 1995 to March 1997. Mr. Jiang is currently vice president of China Non-Government Enterprise Directors Association (中國民營企業家協會) and a rotating chairman of New Shanghai Businessman Federation (上海新滬商聯合會). He graduated in Nanjing Institute of Architecture and Civil Engineering and was admitted to an Executive Master of Business Administration degree at China Europe International Business School in June 2005.

As at the Latest Practicable Date, Mr. Shen was interest in 392,995,000 Shares, representing approximately 5.39% of the issued share capital of the Company within the meaning of Part XV of the SFO of which, 7,865,000 Shares registered in the name of Mr. Shen and 385,130,000 Shares registered in the name of Ansheng Holdings Co., Ltd., the entire issued share capital of which was owned by Mr. Shen. Save as disclosed above, as at the Latest Practicable Date, (i) Mr. Shen did not have any relationship with any Directors, senior management or substantial or controlling shareholders of the Company; (ii) he did not have any interest in the Shares within the meaning of Part XV of the SFO; (iii) he did not hold any other directorships in public companies the securities of which are listed on any securities market in Hong Kong or overseas in the last three years; and (iv) he did not hold other positions with other members of the Group.

EXPLANATORY STATEMENT ON PROPOSED BUY-BACK MANDATE

This appendix contains the particulars that are required by the Listing Rules to be included in an explanatory statement to enable the Shareholders to make an informed view on whether to vote for or against the resolution to be proposed at the 2019 Annual General Meeting in relation to the Proposed Buy-back Mandate.

(1) SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 7,294,369,363 Shares. Subject to the passing of the resolution granting the Proposed Buy-back Mandate and on the basis that no further Shares will be issued or bought back before the 2019 Annual General Meeting, the Company will be allowed to buy-back a maximum of 729,436,936 Shares during the period ending on the earlier of the conclusion of the next annual general meeting of the Company or the date by which the next annual general meeting of the Company is required to be held by law or the date upon which such authority is revoked or varied by a resolution of the Shareholders in general meeting.

(2) SOURCE OF FUNDS

Buy-backs must be funded out of fund legally available for the purpose and in accordance with the Articles and the laws of Hong Kong, the jurisdiction in which the Company is incorporated.

(3) REASONS FOR BUY-BACKS

The Directors believe that it is in the best interests of the Company and the Shareholders to seek a general authority from the Shareholders to enable the Company to buy-back its Shares on the Stock Exchange. Such buy-back may, depending on market conditions, and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and, or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders.

To the best of their knowledge, having made all reasonable enquiries, none of the Directors nor any of their associates currently intend to sell any Shares to the Company or its subsidiaries in the event that the Proposed Buy-back Mandate is approved.

As at the Latest Practicable Date, to the best of the knowledge and belief of the Directors, Mr. Jiang Zhaobai ("Mr. Jiang"), an executive Director and the chairman of the Company, is deemed to be interested in 1,742,300,000 Shares, representing approximately 23.89% of the total number of issued shares of the Company, and was a substantial Shareholder. The interest include: (i) 1,033,300,000 Shares held by Rich Monitor Limited; and (ii) 709,000,000 Shares held by Pengxin Holdings Company Limited, the entire issued share capitals of Rich Monitor Limited and Pengxin Holdings Company Limited are held by Mr. Jiang. By virtue of the SFO, Mr. Jiang is therefore deemed to have an interest in the Shares in which Rich Monitor Limited and Pengxin Holdings Company are interested. In the event that the Directors exercise the Proposed Buy-back Mandate in full and assuming that there is no change in the issued share capital of the Company and the number of Shares held by Mr. Jiang, together with his close associates, remain unchanged, the interests of Mr. Jiang in the issued share capital of the Company would be increased to approximately 26.54%. Accordingly, such increase will not give rise to an obligation to make a mandatory offer under Rule 26 of the Code. The Directors have no present intention to exercise in full the power to buy-back Shares proposed to be granted pursuant to the Proposed Buy-back Mandate.
